### DFG fördert das Projekt "WELRISCC" im Rahmen der CHANSE/NORFACE Förderinitiative Welfare State Responses to Social Risks in Times of Climate Change

We congratulate Dr. Vincent Gengnagel (EUF, Seminar für Soziologie) and his colleagues from universities in Germany, France, Slovenia, UK and Sweden on the successful application for the research project WELRISCC. The project investigates how European welfare states address and manage the social risks arising from climate change. Specifically, the project examines how 16 European welfare states respond to "third-generation social risks" associated with climate change. Leading the work package on ideas of 3rd generation social risk management, Vincent Gengnagel's DFG project adopts a cultural sociologist perspective, aiming to understand underlying moral paradigms, and related social constructions of 3rd generation social risks. This allows, for instance, to capture the role of work ethos or of environmentally friendly behaviour in regime-specific risk constructions - as well as respective anti-transformative motivations. # DFG: Weave Lead Agency Initiative – Collaboration with ARIS (Slovenia) / No Deadline

## Weave Lead Agency Initiative: Kooperationsmöglichkeit mit ARIS (Slowenien)

The German Research Foundation (DFG) has expanded the Weave Lead Agency Initiative to include bi- or trilateral research projects with ARIS (Slovenia). The initiative facilitates collaborative funding opportunities with agencies across Europe, including FWF (Austria), FNR (Luxembourg), NCN (Poland), and others. Proposals are accepted year-round under the Lead Agency Procedure, with DFG acting as Lead Agency for submissions from Germany. #### Collaborative Call for Research in the Humanities with the AHRC

The DFG and the UK Arts and Humanities Research Council (AHRC) announce their seventh collaborative call, aiming to strengthen international partnerships in humanities research. This call supports projects with potential for fundamental advances in human knowledge, requiring a clear joint working program that illustrates the added value of international collaboration. Projects can receive funding for up to three years, starting in early 2026. # ANR-DFG Funding Program for German-French Research Projects in the Humanities and Social Sciences

## Förderung für deutsch-französische Projekte in den Geistes- und Sozialwissenschaften

Since 2007, the joint agreement between the French Agence Nationale de la Recherche (ANR) and the German Research Foundation (DFG) has supported integrated German-French research projects in the humanities and social sciences. The program will open its 19th call for proposals in 2025. This program aims to strengthen German-French cooperation in the humanities and social sciences, fostering sustainable collaborations and networks. While there are no thematic restrictions, the focus is on intensive collaboration and the added value of integrating distinct national academic traditions. Multilingualism is encouraged, particularly in fields where German and French play a significant role as scientific languages. Since 2010, postdoctoral researchers have also been eligible to submit their own proposals in collaboration with researchers from the partner country. Important Notes: No additional funding is available; proposals compete within the general funding framework. Applications must be submitted to both the DFG and ANR by March 6, 2025, 1:00 PM. If applying to the DFG for the first time, you must register in the elan portal by February 27, 2025. Registration confirmation typically takes one business day. Centres enable particularly distinguished researchers to collaborate for the purposes of further developing a research topic in the humanities and social sciences in a certain location. The aim here is to tackle a topic so broadly defined that it ties into existing interests and strengths at the site, while remaining capable of providing a framework for the integration of different individual research concepts. The key characteristics are intensive independent research usually performed by 2-3 responsible researchers – where applicable, made possible through leave of absence – and a fellow programme for visiting researchers from Germany and abroad. Fellowships are awarded to researchers currently at risk outside the EU and those already within the EU. Applications can only be submitted by prospective host institutions in the EU.
